

VERIFIED PETITION FOR SPECIALIZED DRIVING PRIVILEGES

(STAY OF SUSPENSION BY COURT PURSUANT TO 9-30-16-3)

COMES NOW the Petitioner, [name], and being first duly sworn upon oath, petitions for specialized driving privileges as follows:

1. The Petitioner's name is [name] and he is thirty seven (37) years of age, born on .
2. The Petitioner presently resides at
3. That Petitioner is deemed an Habitual Traffic Violator-Life and his driving privileges are suspended by the Indiana Bureau of Motor Vehicles indefinitely.
4. That Petitioner has plead guilty under this cause to Operating After A Lifetime Suspension, 9-30-10-17, and upon conviction, the Court is required to suspend his license for life pursuant to statute.
5. Pursuant to I.C. 9-30-16-3, Petitioner requests that his suspension be stayed and that the Court grant specialized driving privileges.
5. That Petitioner has, in the past, had a valid Indiana driver's license.
6. That Petitioner does not hold a commercial driver's license.
7. That Petitioner has did not refuse to submit to a chemical test offered under I.C. 9-30-6 in this matter.
8. The Petitioner has not previously been granted specialized driving privileges.
9. That upon the Court granting specialized driving privileges, Petitioner agrees to:
 - (a) maintain proof of future financial responsibility insurance during the period of specialized driving privileges;
 - (b) carry a copy of the order granting specialized driving privileges or have the order in the vehicle being operated by the Petitioner; and

- (c) produce the copy of the Order granting specialized driving privileges upon the request of a police officer.

10. This Petition has been served upon the Indiana Bureau of Motor Vehicles and the Allen County Prosecuting Attorney and the Attorney General.

WHEREFORE, Petitioner respectfully requests that the Court stay Petitioner's driving privilege suspension and grant specialized driving privileges as requested hereinabove, and for all other relief that is just and proper in the premises.

_____The driver shall notify the Court in writing of any traffic related arrests or citations within 48 hours of said arrest or citation; and

4. Produce the copy of the Order granting specialized driving privileges and driver's license upon the request of a law enforcement officer.
